## **ORDER**

On March 16, 2020, due to concerns with the coronavirus (COVID-19) pandemic, the Office of the United States Trustee announced the postponement of all meetings of creditors under 11 U.S.C. § 341 scheduled through April 10, 2020. Accordingly, pursuant to 11 U.S.C. § 105(a), it is hereby **ORDERED** as follows:

- 1. This Temporary General Order applies to cases in which the date first set for the § 341 meeting of creditors is on or after March 16, 2020.
- 2. The following deadlines under the Federal Rules of Bankruptcy Procedure are extended in all cases in which the § 341 meeting is continued by the Office of the United States Trustee or by order of this Court to sixty (60) days after the date of the rescheduled § 341 meeting.
- (a) To the extent that the Bankruptcy Code, Bankruptcy Rules, Local Rules or General Orders trigger deadlines caused by the setting of the § 341 meeting which must be complied with after the § 341 meeting is first scheduled, said deadlines are extended sixty (60) days after the setting of the first meeting of creditors; provided that if the § 341 meeting is

further continued by the Office of the United States Trustee or order of this Court, the sixty (60)

days shall run from the newest rescheduled § 341 meeting date.<sup>1</sup>

(b) To the extent that the Bankruptcy Code, Bankruptcy Rules, Local Rules or

General Orders trigger deadlines that must be completed before the setting of the first § 341

meeting of creditors, said deadlines are extended accordingly to run before the first continued

creditor's meeting; provided that if the § 341 meeting is further continued by the Office of the

United States Trustee or order of this Court, the deadlines are extended accordingly to run before

the continued § 341 meeting of creditors.

3. The deadlines under Rule 2003 for holding § 341 meetings are extended to the

extent necessary to accommodate the postponement of § 341 meetings by the Office of the

United States Trustee or order of this Court.

4. Nothing in this Order shall affect the provisions of General Order 20-3 entered March 16,

2020.
